**Workplan:** The grant will take place in the scope of the project Center for Responsible AI. The goal is the implementation of robotic navigation and control algorithms for the robot Vizzy.

**Workplace:** The work will be developed at Instituto de Sistemas e Robótica of Instituto Superior Técnico, under the scientific supervision of Doctor Plinio Moreno López.

**Duration:** The research fellowship(s) will have the duration of 10 months. It's expected to begin in March 2025 and may be eventually renewed up to the maximum of 24 months, including the duration of the initial contract.

Monthly maintenance allowance: the amount of the monthly maintenance allowance is € 990,98€, being the payment method by Wire Transfer.

**Selection methods**: The selection methods will be the following: i) Curriculum evaluation, ii) Programming skills and iii) Robotics/Computer Vision experience with a respective weight of 40%/30%/30%.

**Announcement/ notification of the results**: The final evaluation results will be communicated to all applicants by email.
