### Research Studentships for Master or Integrated Master students

Applications are open for 1 Research Studentship, within the framework of project nº 1801P.01393.1.01 – “Actividades de I&D – Inês Flores-Colen”.

**Scientific Area:** Construction

**Admission Requirements:** *To be enrolled at a master or integrated master.*

**Workplan:** Support in conducting laboratory tests within the scope of developing construction products using oyster shell ans/or textile waste. Support in dissemination and communication of results.

**Legislation and Regulations:** Statute of Scientific Research Fellow, approved by Law nr. 40/2004, of August 18, as worded by Decree-Law nr. 123/2019, of August 28; FCT Regulation for Research Studentships and Fellowships, available on <https://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT2019.pdf> and <https://dre.pt/application/file/a/127230968> .

**Workplace:** The work will be carried out at IST Alameda Campus, under the scientific supervision of Prof. Inês dos Santos Flores Barbosa Flores-Colen and Dr. Maria Paula Sofio Silva Mendes.

**Duration:** The scholarship will have a duration of 3 months, starting in January, 2026. The contract is non-renewable.

**Monthly maintenance allowance:** the amount of the monthly maintenance allowance is €1040.98, being the payment method an option of the Fellow by Wire Transfer/Check.

**Selection methods:** The selection methods will be: curriculum evaluation (50%) and interview (50%). The Jury may decide not to select any candidate if none are considered suitable for the proposed work plan.

**Composition of the selection Jury:** Prof. Inês dos Santos Flores Barbosa Flores-Colen, Prof. Manuel Francisco Costa Pereira and Dr. Maria Paula Sofio Silva Mendes.

**Announcement/ notification of the results:** The final evaluation results will be communicated to all applicants by email.

**Deadlines and procedures of complaint and appeal.** After notification of the provisional list of evaluation results, candidates have a period of 10 working days to, if they wish, make a statement at a preliminary hearing of interested parties, in accordance with Articles 121 et seq. of the Code of Administrative Procedure. The final decision will be made after analyzing the statements presented at the preliminary hearing of interested parties. The final decision may be appealed to the competition jury or to the President of IST-ID within 15 working days of notification.

**Application deadline and formalization:** The call is open from December 22 until December 29, 2025.

It is mandatory to formalize applications with the submission of the following documents: i) B1 Form – Fellowship application (<https://ist-id.pt/recursos-humanos/bolseiros/#documentos-relacionados> ); ii) *Curriculum Vitae*; iii) academic degree certificate, where applicable; iv) proof of enrollment at an academic degree course (Master, Integrated Master); v) motivation letter.
