

Research Studentship (Master or Integrated Master students)

Applications are open for 1 (one) Research Studentship, within the framework of project/R&D institution 1801P.01264 CHARADE IST-ID, 2022.08870.PTDC, financed by national funds through FCT/MCTES (PIDDAC), under the following conditions:

Scientific Area: Engineering and Management of Innovation and Entrepreneurship

Admission Requirements:

- a) *to be enrolled in the master's in Engineering and Management of Innovation and Entrepreneurship (MEGIE);*
- b) *to have knowledge of Economics and Econometrics software, preferably Stata and/or R/RStudio;*
- c) *to be fluent in English (at least C1 level);*
- d) *to have experience in research projects and/or participation in international programs.*

Workplan:

- Develop a literature review within the scope of various Energy Economics topics, such as energy accessibility and poverty, inequality, and digitization;
- Data curation and development of econometric models;
- Write a discussion regarding the main results;
- Development of a master's degree dissertation.

Workplace: The work will be developed at Center for Management Studies of Instituto Superior Técnico (CEGIST), under the scientific supervision of Professor Doctor Maria Margarida Martelo Catalão Lopes de Oliveira Pires Pina and Professor Doctor Inês Isabel Carrilho Nunes.

Duration: The research fellowship(s) will have a duration of 6 (six) months. It is expected to begin in March 2023, and may be eventually renewed up to the maximum of 3 (three) months.

Monthly maintenance allowance: According to the values for Research Fellowships awarded by FCT in Portugal (<http://www.fct.pt/apoios/bolsas/valores>), the amount of the monthly maintenance allowance is € 875,98, being the payment method an option of the Fellow by Wire Transfer/Check.

Selection methods: The selection methods will be the following:

- 1 – Curriculum evaluation (CV and habilitations) (60%);
- 2 – Experience in research projects and/or participation in international programs (20%);

3 – English language level (20%);

In case of a tie between candidates, an interview will be conducted.

Composition of the selection Jury: Professor Maria Margarida Martelo Catalão Lopes de Oliveira Pires Pina, Professor Inês Isabel Carrilho Nunes, and Professor António Manuel da Nave Quintino.

Announcement/ notification of the results: The final evaluation results will be communicated to all applicants by email.

Deadlines and procedures of complaint and appeal. A complaint may be lodged from the final decision within 15 working days, or an appeal to the Executive Board of IST-ID within 30 working days, both counted from the respective notification

Application deadline and formalization: The call is open from March 13 until March 24, 2023.

It is mandatory to formalize applications with the submission of the following documents: i) B1 Form – Fellowship application (<https://ist-id.pt/concursos/bolsas/>); ii) *Curriculum Vitae*; iii) academic degree certificate, where applicable; iv) proof of enrollment at an academic degree course (Master); v) motivation letter.
